

State of the State's Housing



On behalf of the Washington State Housing Finance Commission, the Department of Commerce, and the Washington Low Income Housing Alliance, welcome to Housing Washington 2017!

When we last met for *Housing Washington 2016*, it was on the eve of the presidential election. The world we find ourselves in a year later is a very different one, bringing all new challenges.

For example, the seeming likelihood of corporate tax reform caused upheaval in the tax-credit market which is still depressing prices. Deep cuts to federal housing programs also loom. And the lack of a state capital budget has thrown the Housing Trust Fund into confusion.

Of course, one thing that hasn't changed is the housing crisis facing our nation. Median rents are soaring, especially in metro areas. Homes for sale are in short supply and rising in cost. Rural areas are facing the same housing squeeze as their more populated neighbors, but with fewer resources to address it.

Despite all this, our state is still using the resources we have creatively and efficiently. In 2016 we celebrated the 30th anniversaries of both the Low-Income Housing Tax Credit and the state Housing Trust Fund. We are leading the nation in the effective use of these federal and state resources, which have financed more than 100,000 affordable apartments combined.

Meanwhile, in 2016 alone, almost 8,000 households were able to buy a home through the Commission's home loans and downpayment assistance – a testament not only to resources but to the partnership of lenders, real-estate professionals, community land trusts and Habitat for Humanity affiliates who care about helping lower-income families bridge the gap to homeownership.

I know all of you can point to similar successes against many odds. **Because there's another thing that hasn't changed:** the dedication, creativity, and persistence of our affordable-housing community. What you do is critical for Washington state, and I salute you.

This year's *Housing Washington* will feature speakers and sessions that emphasize hope and solutions for the future. I hope you will once again draw inspiration from your learning and from one another, and go back to your communities with renewed energy for the work that faces us. Enjoy the conference!


