PROGRAM

A Significant Year for Housing



Housing Washington brings together the best and the brightest in our industry. The exchange of ideas, networking and education from our sessions spurs us on each year. This year we are also celebrating the 30th anniversary of two very important housing programs: The Washington

State Housing Trust Fund, one of the first in the nation; and the federal Low-Income Housing Tax Credit Program. Both of these programs have provided Washington with significant resources with which to produce thousands of units of affordable housing. These anniversaries will add a great deal of history and richness to this year's conference.

Since our last conference, the Commission has had a significant year. In the area of enhancing homeownership, our single family homeownership team helped nearly 6,200 families buy homes with mortgage loans totaling approximately \$1.3 billion. Just over 5,100 of those households also received down-payment assistance totaling approximately \$42.8 million.

In the multifamily area, we financed just over 6,500 units of rental housing with loans worth approximately \$855 million. In addition, we made 10 energy efficiency or nonprofit

facilities loans worth \$30.5 million. And finally, we monitored the compliance of 84,800 units of rental housing with income guidelines across the state.

As we approach 2017, we expect to continue enabling home ownership and housing production at a similar level, focusing on new housing and preservation of multifamily rental housing. Increasing solar energy in our multifamily programs is a key priority for the industry and a strong focus for our organization. Finally, with the region's growing aging population, development of more affordable senior housing in the state is vital to meet demands now and in the future.

Along with our conference sponsors, the Housing Finance Division of the Washington State Department of Commerce and the Washington Low Income Housing Alliance, we hope you take advantage of *Housing Washington's* dynamic forum to increase your contacts, learn all you can, and work with your colleagues to take home valuable tools and information to continue building a better affordable housing future for our Washington communities.

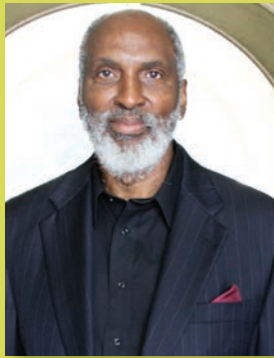

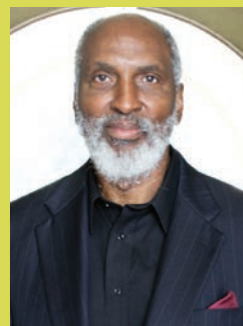

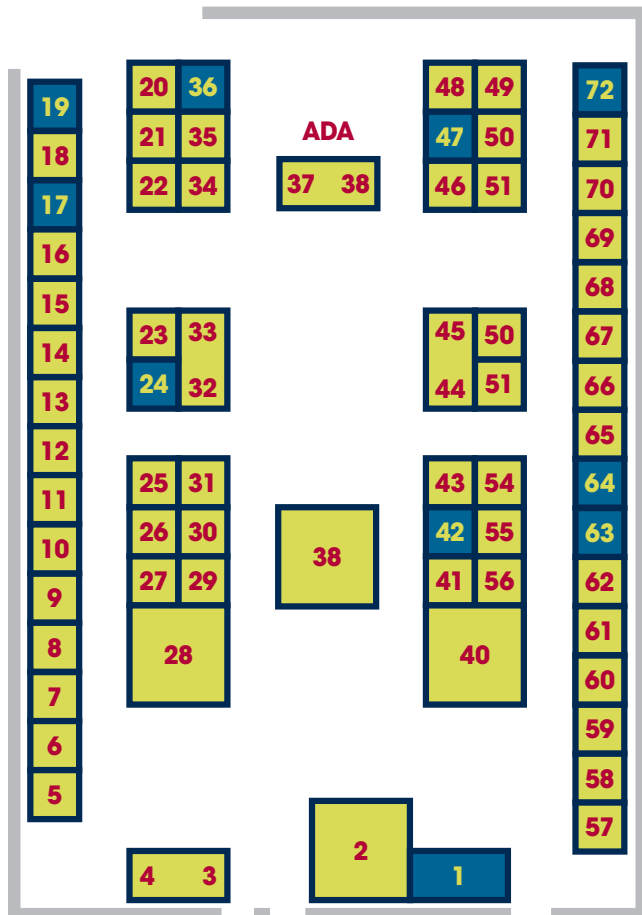
